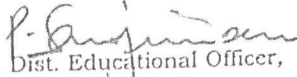

After careful examinations of the proposals received through 4th read above with reference to the instructions under reference 1st to 3rd cited, as per powers delegated through reference 1st cited, the District Educational Officer, Nalgonda is pleased to accord **Renewal Recognition** to **I to VII (E.M)** class(es) U/A for a period of [10] years commencing from the academic year **2019-20 to 2028-29** in respect of **Sneha Prograssive School, Chandoor**, Nalgonda district.

1. That the society shall abide by the instructions / rules regulations made by the Govt. or authorized Officer time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
4. The School timings vacations and Mid-term holidays shall be as prescribed by Government from time to time.
5. That the qualified staff with in the age limits prescribed by the Govt. for Govt. Employees shall be appointed as per the staff pattern.
6. That the results of Institution shall be satisfactory every year.
7. That the records/accounts shall be furnished to the District Educational Officer every year by 30th September at the latest.
8. The list of governing body shall be furnished to the District Educational Officer every year.
9. That the pay structure / Fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.Os and other orders, which are not specified in these orders, shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / D.E.O and competent authority at least 6 months before.
12. That the school shall be closed or permission to close only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. That the School shall be enrolled in DCEB, Nalgonda and following school timings, term holidays like Dasara, Sankranti and declare 2nd Saturday as a holiday strictly.
15. Medical inspection should be done invariably every year
16. The recognition is accorded for **I to VII (E.M)** classes with Single sections (each class) only under Praibha Educational Society and further the management shall have no right to open additional classes/sections without prior permission.

17. The Management has to follow the Government norms from time to time, for collection of fee from students.
18. The School shall run only in the address shown in the proposals. There shall not be any deviation under any circumstances.
19. The RTE Act, 2009 must be implemented. All the admissions, fee, salaries, physical facilities should be as per RTE Act, 2009. Failing which, the Management will be held responsible for consequences.
20. If later found that the school has not fulfilled any as stipulated, the recognition now being given is liable to be withdrawn at once.

The inspecting authority i.e., the District Educational Officer, Nalgonda District has submitted the report for provisional recognition to the school for the years 2016-2017 to 2025-2026 with reference to the conditions laid down in the permission order/previous recognition orders and G.O Ms.No.1Edn, (PS.2) Dept, dt.01.01.1994 vide reference 6th cited.

After careful examination of the references cited and the conditions prescribed in G.O. Ms. No.1/Edn, (PS.2) Dept, dt.01.01.1994 and based on the recommendations of the DEO, Nalgonda Dist., the Regional Joint Director of School Education, Hyderabad hereby accorded Provisional/ Extension of Temporary Recognition to Class(s) VIII to X (E.M) for the years 2016-2017 to 2025-2026 in respect of Sneha Progressive School, Chandur (V&M), Nalgonda Dist. subject to fulfillment of conditions as detailed below:

1. That the Educational Society shall abide by the instructions/rules issued by the Govt. from time to time.
2. That the educational Society shall serve the needs of locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time by the State Government.
4. That the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
5. That the qualified staff within age limits prescribed by the Govt. for Government employees shall be appointed as per the staff pattern as per G.O Ms.No.103 Edn (PS), dt.05-08-2005.
6. That the results shall be satisfactory every year and not to be announce the ranks in SSC Public Examinations as per the G.O Ms.No.49 Edn. (PS), dt.26.02.98.
7. That the records/accounts shall be furnished to the D.E.O every year by 31st March, at the latest.
8. That the list of governing body shall be furnished to the DEO every year.
9. That the pay structure / fee structure fixed by the governing body shall be got approved by the DEO every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall complied with.

11. That the school shall not be closed without giving notice both the Parents/DEO and competent authority at least (6) months before.
12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
14. That additional sections/higher classes should not be opened without prior permission of the competent authority.
15. That the recognition is accorded to society and no other society or body can open a school on their behalf.
16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
17. The society shall provide the necessary material even if it costs more than the deposit amount.
18. Admissions should be made on the basis Record sheet issued by the Private Recognized/ZP/Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bonafide candidate.
19. The Edn. Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt. from time to time by the end of April every year as per G.O.3rd cited.
20. The above E.T.R. is granted subject to condition that, If it is found later that the school has not fulfilled the prerequisite condition under A.P. Edn. Act 1982, reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once.
21. The Management shall provide sufficient transportation, sufficient fire extinguishers in the school.
22. The Management is totally responsible in all aspects for the safety of school children. They will be personally held responsible if any incident occurs.
23. The Management shall handover the school premises whenever required to this department / Government for emergency purpose (Exams/ Elections etc.) without any deviation of the orders.

The recognition now granted is liable for withdrawal by the competent authority for violating the rule as prescribed in the G.O's cited and instructions issued by the authority from time to time.
