RULES AND REGULATIONS

3. (i) MEMBERSHIP : TO ALL
- (ii) CATEGORY OF MEMBERS : General
- (iii) ADMISSION FEE AND THE ANNUAL SUBSCRIPTION OR MONTHLY SUBSCRIPTION : Adm fee 25/-

4. GENERAL BODY :
 - (i) Annual General Body will meet once in a year i.e. in month of July
 - (ii) FUNCTIONS
 - a. To pass the budget for the ensuring year and approve the expenditure statement of Previous Year.
 - b. To approve the reports of the activities of the Society.
 - c. To effect the Executive Committee etc.,
 - d. To appoint Auditor
 - 5.i) Executive Committee : shall consist of Seven (7) Members and out of them , the following of five bearers shall be elected by the E.C.Viz, PPresident . Vice-President , General Secretary , Joint Secretary and Treasurer and remaining persons all the Executive Committee Members.
 - ii) The Members of the Executive Committee (Governing Body) shall be duty bound to atleast the signature of all the members of the newly elected Executive Committee and to see that the signature of the out going Governing Body tally with the annual list as filed with the registrar of societies before 15 days the succeeding month of the month in which Elections were held.
 - iii) FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS :


SIGNATURE OF THE PRESIDENT/SECRETARY.

1. **PRESIDENT :**

He presides over all the meetings of the General Body and Executive committee. He can cast his vote in the case a tie in decision making. He can supervise all branches of the society.

2. **VICE-PRESIDENT :**

He shall assist the President in discharging his functions. In the absence of the President he will perform the duty of the president as entrusted by President.

3. **SECRETARY :**

He is the Chief Executive officer of the society and custodian of all records relating to the society and correspondent on behalf of the society. He has taken on record all minutes of the Society. Would convene both the Executive Committee and General Body of the Society with the permission of the President. He guides the Treasurer in preparing the Budget and expenditure statement to place before the general body for its approval.

4. **JOINT SECRETARY :**

He has to do the work entrusted by the Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary he can perform the duties of the Secretary.

5. **TREASURER :**

He is responsible for all financial transactions and funds of the society. He has to maintain accounts properly along with the vouchers. He has to prepare the accounts of the Society jointly with the secretary or President.

6. **OFFICE BEARERS :**

They are responsible persons to attend to such activities of the society which the Executive Committee entrust to them.

7. **QUORAM :**

2/3 of the total members for general Body meeting and 2/3rd for Executive Committee meeting.

8. **FUNDS :**

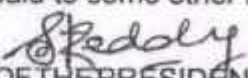
The funds shall be spent only for attainment of the object of the society and no portion thereof shall be paid or transferred directly to any of the members through any means.

9. **AMENDMENTS :**

No amendment or alteration shall be made in the purpose of the association unless it is voted by 2/3 of its members present and at a special meeting convened to the purpose and confirmed by 2/3 of the members present and at a second special meeting.

10. **WINDING UP :**

In case the society has to be wound up the property and funds of the society that remain after discharging the liabilities, if any shall be transferred or paid to some other institutions with similar aims and objects.

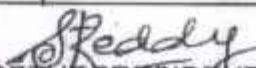
